**3 Matters Arising:**

- **Pecuniary Interest Forms:** Mr M Lovelock asked about Disclosure Pecuniary Interest Forms for those Parish Councillors who this applies to. Parish councillors have been asked for additional information. All confirmed that this information had been completed and returned.
- **Planning Application:** - Lorry Park and Cafe Planning Application on Sausthorpe Road has been approved by East Lindsey Planning Department. Mr. M Lovelock provided the members with an update of his further investigations to the timings of the planning consents, with approval for the illuminated sign being approved before the consent for the Lorry Park. Councillor W Grover agreed to investigate this further.
- **Pothole on roundabout :** This has now been repaired
- **Speeding at Dalby ( A16):** Mr M. Lovelock to ask for a update on this matter. Confirmed that a email has been sent.

6. **Any other Business:** Mrs B Dawson congratulated the Victory Hall Committee on the installation of the plaque in honour of the men from Partney, Dalby, Dexthorpe who served in the World War One. This was unveiled on Saturday 19<sup>th</sup> September 2015. Those present were invited to look at the plaque at the conclusion of the meeting.
  - Councillor W Grover provided information on the Alford & Spilsby Area Committee on Tuesday 1<sup>st</sup> December 2015. Partney Victory Hall as a possible venue. Councillor Grover to liaise with Mr. N . Blanchard regarding booking the Victory Hall.
  - Mr Donnelly raised the issue of the redundant telephone box outside the Victory Hall and possible alternative community uses for the box. Councillor Grover informed the Parish Council of a British Telecom Scheme to adopt a telephone box for £1.00 for community use, such as library and noticeboards.
